

# **TERMS & CONDITIONS NEW ZEALAND**

- ie Terms, the following definitions apply:
  "Blick" means Blick Limited.
  "Confidential Information" means these Terms
  any non-public information relating to Blick and its business (including pricing information) that the Customer may receive or obtain in connection with these Terms.
- "Customer" means the customer any nerson acting customer means the customer, any person action behalf of and with the authority of the custom or any other person, purchasing Goods and Services from Blick.

  - all goods of the general description as attached to or supplied with these Terms; and all goods supplied by Blick to the Custom

  - identified in any invoice, purchase order or similar document issued by Blick to the Customer, which are deemed to be
  - the Customer, which are deemed to be incorporated into and form part of these Terms; and all goods that are marked as having been supplied by Blick or that are stored by the Customer in a manner that enables them to be identified as having been supplied by
  - Blick; and all of the Customer's present and after-acquired goods that Blick has performed work on or to or in which goods or materials supplied or financed by Blick have been attached or incorporated.

"Goods and Services" means all Goods, products, services and advice provided by Blick to the Customer and shall include the manufacture, repair and sale of mining and drilling equipment, industrial equipment and machinery and all associated goods and services and all charges for labour, hire charges, insurance charges, or any fee or charge associated with the supply of the foregoing by Blick to the Customer.

## COLLECTION AND USE OF INFORMATION

- The Customer irrevocably authorises Blick to collect, retain and use any information about the Customer for the purpose of assessing the Customer's credit worthiness, enforcing any rights under these Terms or marketing any Goods and Services provided by
- Blick to any other party. The Customer irrevocably authorises Blick to disclose any information obtained under clause 4.3
- disclose any information obtained under clause 4.1 to any person for the purposes set out in clause 4.1. Where the Customer is a natural person the authorities granted under clauses 4.1 and 4.2 are authorities or consents for the purposes of the Privacy Act 1993.

- The prices to be paid by the Customer for the Goods and Services shall be as stated in Blick's relevant quote or invoice for such Goods and
- Where no quote or invoice is given by Blick, and the price for the Goods and Services is not agreed the price for the Goods and Services is not agreed in writing or agreed to rally between the parties, the Goods and Services shall be deemed to be sold at the then current amount as such Goods and Services are sold by Blick at the time of the contract in accordance with these Terms.

- Payment for Goods and Services shall be made by the Customer in full on or before the 20th day of the month following the date of Blick's invoice, or on receipt of delivery of Goods and completion of Blick's relevant services to the Customer, whichever 61 is the earlier (the "due date").

Interest may be charged by Blick on any amount owing by the Customer after the due date at the rate of 12% per annum, charged at a daily rate and added to the outstanding balance monthly. Any expenses, disbursements and legal costs incurred by Blick in the enforcement of any rights contained in these Terms shall be paid by the Customer indictions are consolated in the state of the content o Customer, including any reasonable solicitor's fees
- Customer, including any reasonable solicitor's fees or debt collection agency fees. Receipt of a cheque, bill of exchange, or other negotiable instrument shall not constitute payment until such negotiable instrument is paid or discharged in full to Blick's satisfaction.
- A deposit may be required by Blick in respect of any Goods and Services and if Blick (at its sole any Goods and Services and it Blick (at its sole discretion) requires the Customer to pay any deposit in advance of receipt of any Goods and Services (whether in whole or in part), but then the Customer fails to do so, there shall be no boligation on Blick to provide such Goods and Services. All deposits shall be non-refundable and may include freight costs, which will also be non-refundable.

### QUOTES

- Where a quote is given by Blick for Goods and

## TITLE AND SECURITY INTERESTS

  Title in any and all Goods supplied by Blick passes to the Customer only when the Customer has made payment in full for all Goods provided by Blick and of all other sums due to Blick by the Customer on any account whatsoever. Until all sums due to Blick by the Customer paid in full, the Customer prants to Blick a Security Interest in all Goods that it supplies to the Customer. If the Goods are attached, fixed, or incorporated into any property of the Customer, by way of any manufacturing or assembly process by the Customer or any third party, title in the Goods shall
- Customer or any third party, title in the Goods shall remain with Blick until the Customer has made remain with Blick until the Customer has made payment for all Goods, and where those Goods are mixed with other property so as to be part of or a constituent of any new Goods, title to these new Goods shall deemed to be assigned to Blick as security for the full satisfaction by the Customer of the full amount owing between Blick and Customer

  Blick shall not be liable for any costs, damages, expenses or losses incurred by the Customer or any third party as a result of any action taken in the exercise of its rights under this clause 9, nor liable in contract or in tort or otherwise in any way. liable in contract or in tort or otherwise in any way hatsoever unless by statute such liability cannot

- demand made in accordance with section 289 of the Companies Act 1993. A Court judgment is entered against the Customer and remains unsatisfied for seven (7) days.

Without limiting the Security Interest granted pursuant to clause 91, the Customer grants to Blick a Security Interest over all of the Customer's present and after-acquired property that Blick has performed any services on or to or in which goods or materials supplied or financed by Blick have been attached or incomportate. incorporated.
- The Customer agrees that Blick may register a financing statement (as that term is defined in section 135 of the PPSA) in relation to any Security Interests granted to it pursuant to these Terms.

### PAYMENT ALLOCATION

- Blick may in its discretion allocate any payment received from the Customer towards any invoice that Blick determines and may do so at the time of receipt or at any time afterwards, and on default by the Customer Blick may reallocate any payments previously received and allocated.
- In the absence of any payment allocation by Blick, payment shall be deemed to be allocated in such manner as preserves the maximum value of Blick's Security Interests granted by the Customer under

No claim relating to Goods and Services may be made by the Customer under these Terms unless it is made in writing to Blick within seven (7) days of delivery of the relevant Goods and Services

### LIABILITY

- The Consumer Guarantees Act 1993, the Fair Trading Act 1986 and other statutes that may imply warranties or conditions or impose obligations upon warranties or conductors or impose obligations upon Blick which cannot by law (or which can only to a limited extent by law) be excluded or modified are expressly excluded by Blick to the maximum extent permitted by law. Blick shall not be liable for any indirect,
- consequential or special loss or damage of any kind whatsoever, including whether suffered or incurred by the Customer or another person and whether in by the Customer or another person and whether in contract or tort (including negligence) or otherwise and irrespective of whether such loss or damage arises directly or indirectly from Goods and Service provided by Blick to the Customer. The Customer indemnifies Blick against all claims and loss of any kind whatsover however caused or arising in connection with any breach by it of these Tares and any periodicens of the Customer.

- Blick does not provide any warranty that the Goods and Services are or will be fit and suitable for the purpose for which they are required by the Customer and shall not be liable if they are not.

## COPYRIGHT AND INTELLECTUAL PROPERTY

Blick owns and has copyright in all designs, drawings, specifications, software, solutions and documents produced by Blick in connection with the Goods and Services provided pursuant to these Terms and the Customer may use the Goods and Services only if paid for in full in accordance with these Terms

## **CONSUMER GUARANTEES ACT**

The guarantees contained in the Consumer Guarantees Act 1993 are excluded where the Customer acquires Goods and Services from Blick for the purposes of a business in terms of section 2 and 43 of that Act

### PERSONAL GUARANTEE OF COMPANY DIRECTORS OR TRUSTEES
